2. The learned Additional Public Prosecutor would submit that the petitioners are complying with the conditions regularly imposed by this Court.

Considering the said submission, the condition imposed on the petitioners are modified to that effect that the first petitioner shall appear before the respondent police as and when required for interrogation and the second petitioner, till filing of the charge sheet, shall appear before the respondent police for monthly once i.e. on first working day of every month at 10.30 a.m until further orders. All other conditions remain unaltered.
