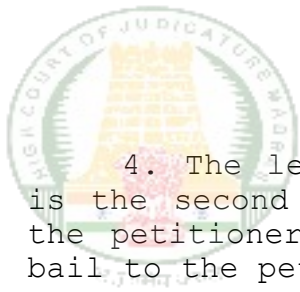
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest for the alleged offence under Sections 385, 506(i) of IPC in Crime No.552 of 2021, seeks anticipatory bail.

2. The case of the prosecution is that the defacto complainant is a BJP Functionary. During the lockdown, he has involved in social work and at that time, one Madurai Bala demanded money from him as mamool. Hence the complaint.

3. The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Hence, he prays for grant of anticipatory bail.



4. The learned Additional Public Prosecutor submitted that this is the second bail application and 3 previous cases pending against the petitioner. Hence, he vehemently opposed to grant anticipatory bail to the petitioner.

5. Considering the facts and circumstances of this case, this is the second bail application and 3 previous cases pending against the petitioner and there is no change in circumstances, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
