2. Heard, Ms.R.Amizhdhu, learned counsel appearing for the petitioner and Mr.A.M.Ayyadurai, learned Government Advocate appearing for the respondents.

Without expressing any opinion on merits of the writ petition, the third respondent is directed to consider the representation of the petitioner dated 14.12.2021, after issuance of notice to the petitioner and the counter parties, if any, by giving them an opportunity of hearing and pass orders on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order, on payment of requisite fee.

4. With the above direction, the Writ Petition is disposed of. No costs.
