PRAYER:-

Writ Petition is filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Mandamus directing the 1st and 2nd respondents to take action against the 3rd and 4th respondents from establishing or running the restaurant or any other outlet with valet parking facility in the Industrial plot comprised in Survey No.38 part and 506 part of Mogappair Village, measuring about 9456 sq.ft. bearing plot No.G-9, 11th street, South Phase, Ambattur Industrial Estate, Ambattur, Chennai-600 058, pursuant to the letter dated 22.12.2021, in Rc.No.117/A8/2021, issued by the 2nd respondent.

The present Writ Petition is filed for a direction to the respondents 1 and 2 to take action against the respondents 3 and 4 from establishing or running the restaurant or any other outlet with valet parking facility in Industrial plot comprised in Survey No.38 part and 506 part of Mogappair Village, measuring about 9456 sq.ft. bearing plot No.G-9, 11th street, South Phase, Ambattur Industrial Estate, Ambattur, Chennai-600 058, pursuant to the letter dated 22.12.2021, in Rc.No.117/A8/2021, issued by the 2nd respondent.
