2. The petitioner seeks mandamus directing R1 and R2 to forthwith grant electricity service connection to the petitioner's residential house at No.1/546, Krishna Nagar, Periyar Salai, Near Electricity Board Office, Manapakkam, Kancheepuram District - 600 115.

Ms.Keerthana will assure the Court that electricity connection be provided to the petitioner within a week from today seeing as the indemnity bond has been provided by the petitioner as per Regulation 27(4) of the Tamil Nadu Electricity Distribution Code, 2004 which would override the objections made by the land owner.

4. Recording the aforesaid, this Writ Petition is disposed. No costs.
