ORDER

The petitioner has filed this writ petition seeking issuance of a Writ of Mandamus to direct the 1st respondent to furnish the entire proceedings in Na.Ka.No.A2/3712/2021 and order cancelling the Patta No.14137 issued in the petitioner's name in respect of the property situated at No.142 Palavakkam Village, Saidapet Taluk, comprised in S.No.36/1 measuring an extent 22 cents.
