This is an application to seek condonation of delay of 755 days in re-presenting the appeal.

2. The appeal has been filed to challenge the order dated 21.03.2018 passed in W.P.No.30787 of 2013. On perusal of the affidavit filed in support of the application, we do not find any plausible reason to condone the delay. We also do not find any infirmity in the order impugned and accordingly, we see no ground to condone the delay of 755 days in re-representation.

Accordingly, this application to condone the delay is dismissed. Consequently, the Writ Appeal is rejected at the SR stage itself.

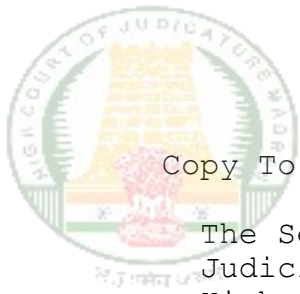
