This petition is filed to modify the condition imposed on the petitioner by order dated 13.04.2017 in Crl.M.P.No.5266 of 2017 in Crl.A.No.215 of 2017 to appear before the learned Special Judge-cum-Judicial Magistrate Court, Cuddalore on the first Monday of every English Calendar month at 10.30 a.m until further orders.

2. Learned counsel for the petitioner submits that the petitioner is complying with the condition imposed by this Court regularly except during the lock down period and therefore, has filed this petition, seeking to modify the condition imposed by this Court.

3. Heard the learned Additional Public Prosecutor and he also submits that the petitioner has been complying with the condition regularly except the lock down period.



4. Considering the fact that the petitioner is aged about 73 years and he is regularly complying with the condition imposed by this Court, the condition imposed by this Court is modified to the effect that the petitioner shall appear before the Special Judge-cum-Judicial Magistrate Court, Cuddalore at 10.30 a.m on the first working day of once in three months of English Calendar month, commencing from 01.04.2022 until further orders.

5.The petition is ordered accordingly.
