PRAYER: This Writ Petition has been filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, calling for the records from the 1st respondent relating to impugned order dated 08.06.2010 vide letter No.Na.Ka.Vi.ni./3(3)28283/2010 and quash the same and consequently direct the 1st respondent to pass an order by extending the service of the petitioner to the post as Tutor-cum-Wardon for a period of two years from 01.07.2010.
