Prayer : Writ Petition filed Under Article 226 of the Constitution of India, to issue a writ of Certiorarified Mandamus, calling for the records relating to the impugned rules framed by Notification III made in G.O.(Ms) NO.15 Rural Development (E1) Department dated 25.1.2000 issued by the 1st

respondent and the consequential Panel for the year 2015-16 for promotion as Assistant Executive Engineers (RD) issued by the 2nd respondent in his proceedings RC No.17053/2015/EE1 dated 6.8.2015 and quash the same as illegal and consequently direct the respondents to draw a fresh panel by adopting the ratio for appointment to the post of Assistant Executive Engineer from the category of Assistant Engineers and from the combined categories of Junior Engineers and Senior Draughting Officers as 6:3 within the period that may be stipulated by this Hon'ble Court.

ORDER
