The petitioner submitted a representation dated 07.10.2019 and reminder representation dated 28.11.2019 to measure the boundaries the property comprised in S.Nos.141/1, 141/2, 141/3, ad-measuring an extent of 2.20 acres of land, which are situated at Manivilunthan Village, Attur Taluk, Salem District before the respondents. The petitioner also paid requisite fees. On receipt of the same, the second respondent measured the subject properties and the respondents have not yet served any survey report to the petitioner.
