PRAYER IN W.P.NO.6570 OF 2010:-

Writ petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus to call for the records relating to the order passed by the 2<sup>nd</sup> respondent in his letter No.5971/B1/2009 dated 09.12.2009 and quash the same thereby direct the 2<sup>nd</sup> respondent to take steps to compel the 3<sup>rd</sup> respondent association under the provisions of the Tamil Nadu Societies Registration Act 1975 to apply for registration under Section 4 of the said Act within a date fixed by this Court failing which the 2<sup>nd</sup> Respondent may be directed to take action against the 3<sup>rd</sup> respondent association under Section 46 of the Tamil Nadu Societies Registration Act 1975.

PRAYER IN W.P.NO.25370 OF 2009:-

Writ petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing the 1<sup>st</sup> respondent to take steps to compel the 2<sup>nd</sup> respondent association according to the provisions of the Tamil Nadu Societies Registration Act, 1975 and apply for registration within a date fixed by this Court, failing which the 1<sup>st</sup> Respondent may directed to take steps against the 2<sup>nd</sup> Respondent according to the Tamil Nadu Societies Registration Act. (Prayer amended as per Order dated 11/01/2010 in M.P.No.1 of 2010 in W.P.No.25370 of 2009)
