ORDER

According to the learned counsel for the petitioner, this Court by order dated 11.09.2013 passed in M.P.No.2 of 2013 in W.P.No.25293 of 2013 granted interim stay, directing the respondents to permit the petitioner to continue services until further orders. Since the respondent had not complied with the interim order of this Court, the instant contempt petition is filed.

2. On perusal of the interim order passed by this Court, the petitioner has requested to grant re-employment in the same post from 01.09.2013 to 31.05.2014. Since the said academic year is over, at this
