Though the petition is filed for transferring the H.M.O.P.No.20 of 2022 filed by the Respondent herein pending on the file of the Sub-Court, Alandur, Kanchipuram District and transfer the same to the Principal Sub-Court, Kanchipuram, Kanchipuram District, however, considering the fact that the residence of the petitioner is at Vettuvankani, which falls within the jurisdiction of the Sub-Court, Alandur, on consent of
