Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, to direct the first respondent to pass orders on the petitioner's representations dated 10.07.2013 allotting light duties in the Police Radio Branch (Maintenance), Nagercoil considering the deteriorating health condition of the petitioner and also considering the various treatments to be performed to the petitioner in various hospitals in the light of the earlier order passed by the Hon'ble Court in WP.No.11312 of 2013 dated

19.04.2013 after setting aside the proceedings of the third respondent by usurping powers to the exercised by the first respondent made in C.No.A3/9225/2013 dated 10.07.2013, contrary to the order passed by this Court made in W.P.No.11312 of 2013 apart from cancelling the order passporting the petitioner to Armed Reserve, Nagercoil by the third respondent and the VRS application dated 09.07.2013 forcibly obtained by the fourth respondent by threat and coercion.

ORDER

The petitioner seeks for a direction to the first respondent to allot light duties in the Police Radio Branch (Maintenance) at Nagercoil.
