Considering the fact that the petitioner is regularly complying the condition and the fact that the petitioner is 72 years old, the condition is relaxed and that the petitioner is directed to appear before the Special Judge and Chief Judicial Magistrate, Erode on the first working day of April, July, October and January at 10.30 a.m. and the other conditions remain unchanged.
