4. Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl. Side) that the condition imposed vide order dated 07.12.2021 made in Crl.O.P.No.23530 of 2021 is modified to the effect that the petitioner Nos.1 & 3 shall appear before the respondent police, on the first working day of every month at 10.00 a.m., till filing of the final report. Since the second petitioner is a College student, the condition imposed on the second petitioner to report before the respondent police, is relaxed.
