2. The Writ Petition had been filed challenging the G.O. Ms. No. 697, Home (Transport-5) Department dated 05.08.2010 and an Order in R. No. 22370/H1/2008 dated 17.06.2015 passed by the Second Respondent insofar as it relates to the driving school of the Petitioner.

4. It has been brought to notice that after the filing of the Writ Petition, the impugned orders have been modified by G.O. Ms. No. 215, Home (Transport-5) Department dated 05.05.2022 in furtherance to the order dated 15.09.2015 in W.P. No. 19362 of 2015 etc., batch passed by the Court and it has been decided to allow the Heavy Vehicles Driving School to conduct one day refresher training to the Heavy Vehicles Driver so as to issue Certificates to
