2. The Writ Petition has been filed challenging G.O. Ms. No. 697, Home (Transport-5) Department dated 05.08.2010 issued by the First Respondent and Order in R. No. 22370/H1/2008 dated 17.06.2015 passed by the Second Respondent insofar as it relates to the driving school of the Petitioner.

4. It has been brought to notice that after the filing of the Writ Petition, the impugned orders have been modified by G.O. Ms. No. 215, Home (Transport-5) Department dated 05.05.2022 in furtherance to the order dated 15.09.2015 in W.P.
