#### ORDER

In this Writ Petition, the petitioner is aggrieved by the grant of No Objection Certificate (NOC) in favour of 8<sup>th</sup> respondent.

2. It is submitted by the learned Additional Government Pleader appearing for the respondents 1 to 7 that the present Writ Petition is not maintainable in view of the fact that the petitioner has not challenged the NOCs issued in favour of 8<sup>th</sup> respondent but has only sought for a mandamus.

3. The learned counsel for the petitioner submits that the petitioner has not received the copy of the NOCs issued in favour of 8<sup>th</sup> respondent and only on receipt of the same, the petitioner will be in a position to challenge the same in the manner known to the petitioner under law.

4. The learned Additional Government Pleader appearing for the respondents 1 to 7 would submit that if a direction is issued by this Court, copies of the NOCs will be issued to the petitioner, within a time frame to be fixed by this Court.

5. After recording the rival submissions, this Writ Petition is disposed of, by directing the official respondents 1 to 7 to issue the NOCs granted in favour of 8<sup>th</sup> respondent which is the subject matter of the Writ Petition, within a period one (1) week from the date of receipt of a copy of this order. On receipt of the said NOCs from the respondents 1 to 7, the petitioner is granted liberty to challenge the same in a manner known to the petitioner under law. No costs.
