Today, when the matter is taken up for hearing, learned Additional Government Pleader appearing for the respondents 1 to 3 submitted that the Government have examined the proposal of the Director of Sugar and based on the 50th Area Delimitation Committee Meeting, decided to accept the same. He has produced G.O.(Ms) No.244, dated 5/10/2018, and further submitted that G.O., has been implemented successfully. Therefore, question of challenging the delimitation does not arise at all. Hence, prays for dismissal of the writ petition.
