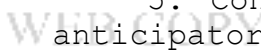
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehends arrest by the respondent police for the offences punishable under Sections 379, 430 of IPC r/w Section 21(5) of Mines & Minerals (Development & Regulation) Act, 1957, r/w Section 3(2) of TNPPDL Act, in Crime No.401 of 2019 is before this Court seeking anticipatory bail.

2. The case of the prosecution is that while the respondent police was on regular partolling, the petitioner illegally transported lake sand in bullock cart, without any valid license. Hence, the complaint.

3. The learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has not committed any such offences as alleged by the prosecution. He further submitted that he has been falsely implicated in this case. Hence, he prays to grant anticipatory bail to the petitioner.
