2.*Prima facie*, the writ petition is not maintainable as the respective writ petitioners are seek to enforce/invoke the civil remedy to restrain the 5th respondent from interfering with the possession of the property, which belongs to the 5th respondent. Therefore, there is no merits in the writ petition.

3.Accordingly, this writ petition is dismissed with the above observations. However, liberty is given to the respective petitioners to work out their remedy before the Civil Court having Jurisdiction. No costs. Consequently, connected miscellaneous petition is closed.
