Advocate (Crl. Side) on behalf of the Respondent, [IN BOTH THE PETITIONS] the court made the following order:-

These petitions have been filed to relax the conditions in Crl.O.P.Nos.20370 & 20374 of 2021 dated 29.10.2021.

2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side).

3. The petitioner herein was granted anticipatory bail on 29.10.2021 and he has not complied the condition. But he has filed two petitions to relax the condition.



4. This Court, on considering the reason stated by the petitioner herein finds that, they are not genuine and after enjoying the interim protection, the petitioner has not dare to comply the order of this Court, for nearly three months and has come before this Court after sensing that, the police may take action against him. The violation of the condition cannot take advantage of it and come to the Court leisurely seeking relaxation.

5. Hence, this Criminal Original Petition is dismissed. Consequently, anticipatory bail granted will cancel for non-compliance of the condition.
