V.BALAMURUGANE, Public Prosecutor for Puducherry on behalf of the Respondent the court made the following order:-

The petitioner herein, who jumped Bail, was subsequently arrested and granted bail on condition that he should report before the respondent Police daily. The present petition is filed to relax the said condition on the ground that on completion of investigation, final Report filed and the same has been committed to the Sessions Court and assigned in S.C.No.47 of 2021 and pending before the learned III Additional District and Sessions Court, Puducherry.

Taking note of the fact that the petitioner is one of the accused in a murder case involving explosive substance and he has already jumped bail, in order to ensure his presence during the Trial and examination of witness, the Bail condition is modified to the effect that, he shall report before the concerned Sessions Court, where the case is pending, every Friday at 4.30 p.m. until further orders.
