Writ Petition is filed under Article 226 of Constitution of India, pleaded to issue a Writ of Mandamus, directing the 1st and 2nd respondents to grant permission to conduct the Cultural programme of Adal Padal on 13.03.2022 at 06.00 p.m. to 11.00 p.m., at "Sri Vembuli Amman Temple Festival", Kizhvilachur Village, Vaduganthangal Post, K.V.Kuppam Taluk, Vellore District by consider and pass orders on the representation dated 28.02.2022 made by the petitioner within the time frame as may be fixed by this Hon'ble Court.

(g) similarly, the Police is empowered to stop the programme, if it exceeds beyond the permitted time;

(h) the participants of the programme shall not intake any kind of in-toxic substance or liquor during the programme;

(i) if any untoward incident takes place, the organizers of the programme be made responsible for the same;

(j) the authority concerned shall videograph the entire programme at the cost of the applicant and submit the CD to the S.P concerned;

(k) Organizers shall have to obtain all other required permission from the authorities concerned;

(l) Any other conditions as the authority concerned consider to impose according to the ground reality".

5. The petitioner is also directed to ensure that the conditions are strictly complied with and also to ensure that no law and order problem is created in the course of conducting the programme. Further, the petitioner is directed to pay a sum of Rs.15,000/- (Rupees Fifteen Thousand only) to the respondent police towards bundobust charges.

6. The Writ Petition stands disposed of with the above directions. However, there shall be no order as to costs.
