2.The learned Counsel appearing for the petitioner submitted that the respondents having fully known that the above mentioned lands are owned by the petitioner and consequent issuance of patta in her name, the attempt of the respondents in encroaching upon the private land without any right or authority is illegal and hence prays for appropriate orders.

3.The learned Government Advocate appearing for the respondents submitted that without following the due process of law, the petitioner's property will not be disturbed.

4.Recording the same, this Writ Petition is closed. No costs. Consequently connected miscellaneous petition is closed.
