Name Transfer / D.No.111/2015-2016 dated 19.06.2015 whereby the electricity service connection no.030:015:235 (Tariff LA1A) for the premises at New Door No.37, Old Door No.15, 2nd street, K.C.Garden, Peravallur, Chennai – 600 082 is transferred from the name of the petitioner to the name of the 3rd respondent and quash the same as illegal and direct the respondents 1 & 2 to restore the said electricity service connection in the name of the petitioner.
