This petition has been filed to relax the conditions imposed in Crl.OP.No.21088 of 2021 dated 28.02.2022.

The learned Government Advocate (Crl.Side) appearing for the respondent police has submitted that the investigation has been completed, hence, the petition for relaxation is modified to the effect that petitioners shall report before the Investigation Officer daily at 4.00 p.m., instead of daily at 10.00 a.m.

However, considering the difficulties expressed by the petitioners to report before the Investigating Officer daily at 10.00 a.m., for a period of 15 days commenced from 10.03.2022 and shall co-operate for investigation, is modified to the effect that the petitioners should report before the Investigating Officer daily at 4.00 p.m., until further orders.
