This petition has been filed to modify the condition to report before the respondent police daily at 10.00 a.m. for a period of fifteen days imposed upon the petitioner in Crl.OP.No.4514 of 2022 dated 24.02.2022.

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl. Side) appearing for the respondent police.

Considering the facts and circumstances of the case and also considering the submission made by the learned counsels on either side, this miscellaneous petition is allowed and the condition imposed vide order dated 24.02.2022 made in CrI.OP.No.4514 of 2022 is modified to the effect that "the petitioner shall report before the Kancheepuram Town Police Station, Kancheepuram daily at 10.00 a.m. for a period of 15 days and thereafter as and when required for interrogation".
