The above petition is filed seeking permission to withdraw the entire amount of Rs.19,27,895/-, which has been deposited by the first respondent/appellant to the credit of M.C.O.P.No.274 of 2016 on the file of the Motor Accident Claims Tribunal, (Special Sub Court No.2), Chennai,

2. The appellant has filed the appeal restricting to a sum of Rs.15,00,000/- (Rupees fifteen lakhs only).

3. Considering the same, the petitioner is permitted withdraw the sum of Rs.14,00,000/- (Rupees fourteen lakhs only) from out of the sum deposited to the credit of M.C.O.P.No.274 of 2016.
