The learned Government Advocate appearing on behalf of the official respondents submitted that the challenge has been made to the notice issued by the 2nd respondent based on the complaint instituted by the 4th respondent. However, pending the petition enquiry was conducted, and after affording opportunity to all the aggrieved persons, the 2nd respondent closed the complaint in the year 2013 itself holding that there is no element of land grabbing by order dated 25.09.2013. Hence, nothing survives for further adjudication.

3. Recording the same this Writ Petition is closed. No costs. Consequently, connected miscellaneous petitions are closed.
