2.The leaned counsel appearing for the petitioner submitted that in respect of the subject property already a suit was filed before the competent Civil Court and it ended in favour of the third respondent, as against which, the petitioner has preferred appeal before the lower Appellate Court and hence nothing survives for adjudication in this writ petition.
