



3.The learned Additional Public Prosecutor submits that, out of 14 accused the prime accused is still in abscondance and yet to be secured. Some of the accused persons have bad antecedents and detained under Goondas and as far as this petitioner is concerned, he is having one previous case.

4.Considering the fact that this petitioner was arrested on 23.01.2022 and he was a part of the unlawful assembly, only as the member of the auto driver association and one previous case against him, this Court is inclined to grant bail to this petitioner.

5. Accordingly, the petitioner is ordered to be released on bail subject to the following conditions;

(a) the petitioner shall execute a bond for a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)** with two sureties, each for a like sum to the satisfaction of the learned **District Munsif cum Judicial Magistrate, Uthukottai;**

(b) the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the learned Magistrate may obtain a copy of their Aadhar Card or Bank Pass Book to ensure their identity;

(c) **the petitioner is directed to appear before the Pallipet Police Station daily at 10.30 a.m. until further orders;**

(d) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala** [(2005)AIR SCW 5560];



(f) if the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
