Prayer in W.P.No.20525 of 2018: Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Certiorari, to call for the records of the third respondent Na.Ka.No.813/B4/2017 dated 14.5.2018 approving the appointment of the fourth respondent as the Correspondent of the Education Committee (Adyar Range), quash the same.

Prayer in W.P.No.20526 of 2018: Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Mandamus, to direct the first respondent herein to consider the representation of the petitioner with respect to the approval of the appointment of the fourth respondent as the Correspondent of the Education Committee (Chennai Central Range) of the fifth respondent society and consequently direct the first respondent to reject the approval granted to the fourth respondent on the ground that the same is against the byelaws of the fifth respondent society.

Prayer in W.P.No.20527 of 2018: Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Certiorarified Mandamus, to call for the records of the fifth respondent dated 14.4.2018 and the consequential approval of the second respondent in Na.Ka.No.1467/A3/18 dated 25.5.2018 approving the appointment of the fourth respondent as the Correspondent of the Education Committee (Chitlapakkam and Thirupporur Ranges) of the fifth respondent society, quash the same, and consequentially direct the respondents to call for the applications to the post of Correspondent of the Education Committee of the fifth respondent society and conduct the
