This Civil Miscellaneous Petition has been filed, to condone the delay of 1736 days in filing the above writ appeal.

2. Considering the averments made in the petition, this petition is allowed on condition that the appellant pays a sum of Rs.50,000/- [Rupees Fifty Thousand Only] out of which Rs.25,000/- (Rupees Twenty Five Thousand Only) to the **Anandam Home for Senior Citizens, Anna Street, Gangai Nagar, Kallikuppam, Ambattur, Chennai 600 053. Mobile Nos.9444953268 / 9710446131** and balance amount of Rs.25,000/- (Rupees Twenty Five Thousand Only) to the writ petitioner on or before 10.06.2022, failing which, petition to condone the delay, would stand dismissed, without further reference to this Court.

4. C.M.P.No.5188 of 2022 is ordered, accordingly.
