PRAYER : Writ Petition filed Under Article 226 of the Constitution of India, to issue a writ of Certiorarified Mandamus, to call for the records on file of the 3rd respondent in proceedings Na.Ka.No. 904/E3/2015 dated 29.08.2015 and quash the same as illegal, incompetent and without jurisdiction and further direct the 1st respondent to extend the period (May 2015-March 2016) to the petitioner for running Aavin Milk Parlour in the 3rd respondent college.

ORDER

The order impugned passed in the year 2015 states that the petitioner was running Aavin booth at Chidambaram, Government Kamaraj Hospital, without renewing his licence.

2.The learned counsel for the petitioner states that the



petitioner submitted an application seeking renewal of licence, however, it was not considered.

3.The learned Special Government Pleader made a submission that the Government took a policy decision to conduct open public auction in respect of the shops to be allowed inside the Government Hospitals and Medical College Hospitals. Thus, the petitioner has to renew the licence or the authorities are bound to conduct public auction by following the procedures as contemplated. In this regard, the respondents are permitted to take a decision and accordingly, follow the procedures as contemplated.

4.With these observations, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
