O R D E R

The petitioner herein filed this writ petition, seeking a direction to the respondents 8 and 9 to consider his representation dated 10.11.2013 and take appropriate action against the respondents 1 to 7 for disqualification of their membership from the board and their removal from their office.

2. The writ petitioner by referring to the surcharge proceedings initiated against the respondents 1 to 7 under 87 of Tamil Nadu Co-operative Societies Act submitted a representation to statutory authorities



namely the respondents 8 and 9 to take appropriate action against the petitioners 1 to 7.

3. In view of the limited prayer in this writ petition, without going in to the merits of the representation made by the writ petitioner, this Court is inclined to issue a direction to the respondents 8 and 9 to consider the representation of the petitioner dated 10.11.2013 and pass appropriate orders in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With this observation, the writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
