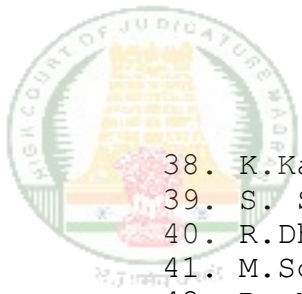

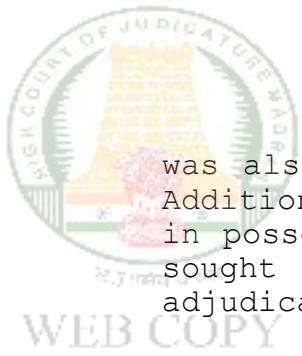

COMMON ORDER

Since the issue involved in both these writ petitions is one and the same, these writ petitions are disposed of by way of a common order.

2. When the writ petitions are taken up for hearing, the learned Additional Government Pleader fairly submitted that during the pendency of these writ petitions, the possession of the subject lands were taken, Award was passed and the project



was also implemented. Therefore, it is submitted by the learned Additional Government Pleader that the petitioners are no longer in possession of the subject matter of the lands and the relief sought for in these writ petitions no longer survives for adjudication by this Court.

3. The learned counsel for the petitioners did not dispute the said submission made by the learned Additional Government Pleader appearing for the respondents.

4. Recording the aforesaid submissions made by learned Additional Government Pleader appearing for the respondents, these writ petitions are dismissed as having become infructuous. However, liberty is granted to the petitioners to work out their remedy, if any, in the manner known to law for seeking compensation. No costs. Consequently, connected miscellaneous petitions, if any are closed.
