Today, when the matter is taken up for hearing, the learned Additional Government Pleader appearing for the respondents would submit that the Cheque bearing No.040377, drawn at State Bank of India, for Rs.2,64,411/, is handed over to the petitioner, being part of the payment which are payable to the petitioner in the writ petition. He would also submit that the remaining outstanding amount shall also be paid in due course of time.

3. The respondents are directed to pay the remaining amount within a period of eight weeks from the date of receipt of a copy of this order.
