Prayer in W.P.No.20900 of 2016 :- Writ Petitioner filed a Writ of Mandamus to direct the respondents 1 to 3 to pay and settle the petitioner forthwith a sum of Rs.1,50,000/- payable under Family Benefit Scheme after adjusting a sum of Rs.5,000/- which was paid towards funeral expenses together with interest at the rate of 12% per annum; to pay the petitioner gratuity, provident fund, earned leave and medical leave salary, the amount payable under the social security scheme, IRT contribution and family pension from the date of death of her husband with arrears and other consequential benefits as revised from time to time, together with interest at the rate of 12% per annum till the amounts are actually paid and within the time limit and award costs.
