ORDER

The above revision is filed by the petitioner seeking to strike off I.A.No.9 of 2022 filed in I.A.No.3 of 2022 in O.P.No.2417 of 2021 pending before the II Additional Family Court, Chennai.

2. The relief claimed in I.A.No.9 is as follows:

"to recall the petitioner and permit the petitioner/respondent to mark the documents as exhibits in application for visitation rights by in I.A.No.3 of 2022 in O.P.No.2417 of 2021."

3. The learned counsel for the petitioner submitted after making her arguments that the petitioner has no objection for this petition in I.A.No.9 being ordered and therefore this Court has passed order without issuing notice to the respondent.

4. Therefore, directions are issued to the Additional Family Judge, Chennai to proceed to hear the I.A.No.3 which is filed by the petitioner mother seeking temporary custody of her 3 children aged 11, 9 and 5 respectively.
