The learned Government Advocate (Crl.Side) appearing for the respondent police has submitted that the investigation is not yet completed, hence, the petition for relaxation is modified to the effect that the petitioner shall report before the learned Special Court under EC and NDPS Cases, Salem once in a month instead of every Wednesday at 10.30 a.m.

Recording the same, the conditions imposed on the petitioner to report before the Investigating Officer on every Wednesday is modified to the effect that she should report before the learned Special Court under EC and NDPS Cases, Salem on first working day of every month at 10.30 a.m., until further orders.
