ORDER

4.It seems that the suit is said to be pending at the stage of filing additional written statement of other defendants, but the defendants did not choose to appear. Under such circumstances, the Court has to pass necessary orders and take the proceedings to the next stage. Due to high value involved in the suit, it will be appreciable, if the learned trial Judge dispose of the suit as expeditiously as possible.

5.Therefore, this Civil Revision Petition is disposed of and the learned I Additional District Munsif, Salem is directed to dispose of the suit in O.S.No.83 of 2020 as expeditiously as possible. No costs.
