The learned Government Advocate appearing for the respondents would submit that the period for the Thiruppani Committee which was appointed was already expired and he has also filed a copy of the report issued by the Thakkar of Arulmigu Mariamman Selvavinayagar Thirukkcoil, Goundampalayam. He would further submit that 80% of the construction work in the temple is over. Therefore, nothing survives in this writ petition.
