This Criminal Miscellaneous Petition has been filed by the petitioner to extend the time to comply with the condition made in Crl.O.P.No.3010 of 2022, dated 16.02.2022.

2. This Court on 16.02.2022, while granting anticipatory bail to the petitioner imposed a condition that the petitioner should execute a bond for a sum of Rs.25,000/- with two sureties each before the learned Judicial Magistrate, Thiruthuraipoondi, within a period of fifteen days.

3. The learned Government Advocate (Crl. Side) appearing for the respondent submits that the above stated condition was not complied by the petitioner.



4. The learned Counsel appearing for the petitioner states due to serious health condition of his mother and he has to immense necessity to look after his mother, he was not able to comply the conditions within a time stipulate by this Court.

5. Taking note of the submissions made by the learned counsel for the petitioner, for executing sureties time is extended till 18.04.2022, with a condition that no further extension of time will be granted failing which, the bail granted will be automatically cancelled without any reference to this Court.
