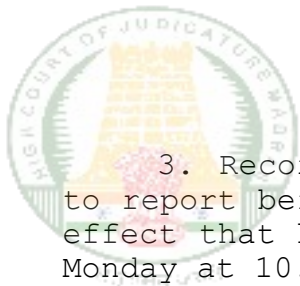

This petition has been filed to relax the conditions imposed in Crl.OP.No.1607 of 2022 dated 25.01.2022.

2. The learned Government Advocate (Crl.Side) appearing for the respondent police has submitted that the petitioner has not complied with conditions for last one week and investigation is not completed. Hence, the petition for relaxation is modified to the effect that the petitioner shall report before the Investigating Officer once in a week instead of daily at 10.30 a.m.



3. Recording the same, the conditions imposed on the petitioner to report before the Investigating Officer daily is modified to the effect that he shall report before the Investigating Officer on every Monday at 10.30 a.m., until further orders.
