He would assure the Court that the application of the petitioner dated 14.12.2021 will be forwarded to R3 within 48 hours from today, upon receipt of which R3 will issue notice to the parties and dispose the application in accordance with the aforesaid Act and all other applicable regulations. In light of the order that is passed now, no notice is necessary to R4 at this stage.
