Pleader appearing for the Respondents herein; and upon perusing the Application and affidavit of Sivaselvam, filed herein; the Court made the following order:-

"This petition has been filed seeking to re-open Contempt Petition No.547 of 2020.

2.This Court vide order dated 25.11.1999 made in W.P.No.32894 of 2019 issued direction to the respondents therein to dispose of the petitioner's representation within a time frame.

3.When the contempt petition was taken up for consideration on 18.09.2020, it was represented by the learned Special Government Pleader that the petitioner's representation was considered and the same was disposed of and the petitioner was informed that there is no vacancy in the post of Staff Nurse at Thoothukudi District.

4.Perusal of the records disclosed that in compliance of the order dated 25.11.1999 made in W.P.No.32894 of 2019, the petitioner's representation was considered and appropriate orders were passed on
