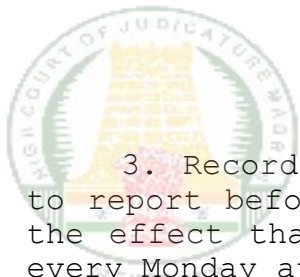

3. Recording the same, the conditions imposed on the petitioner to report before the Investigating Officer everyday is modified to the effect that he shall report before the Investigating Officer on every Monday at 10.30 a.m., until further orders.
